ACTION ITEMS:

STATEMENT OF OPPOSITION, CASE NO. 2019CW3032, APPLICATION OF SALIDA

Lee Miller reported this case seeks to modify an existing augmentation plan adjudicated by the City of Salida (City). The modification is being made to add two wells located in Fremont County to the structures augmented by the plan. The augmentation plan provides for delivery of augmentation water at Pueblo Reservoir and an exchange from Pueblo Reservoir. The amount of water is small – 25 af/yr; 0.11 cfs – and Project water expressly will not be used in the augmentation of the additional structures.

The District and the Bureau of Reclamation (Reclamation) share three issues of concern with the City's proposed operations: (i) potential impact on the VFMP; (ii) potential impact on the Winter Water Storage Program; and (iii) the City's use of Pueblo Reservoir as a storage facility. The District and Reclamation have begun conversations with the City's water attorney and are working on resolutions for the issues. The Bureau of Reclamation is unlikely to file a Statement of Opposition, instead is working with the District to address mutual concerns.

Mr. Goodwin moved, seconded by Mr. Hamel, that the District Board authorize the filing of a Statement of Opposition by Special Water Counsel in Case No. 19CW3032 – City of Salida. Motion unanimously carried.

Mr. Vaughan reported Mt. Elbert Conduit is currently off. Reclamation is currently not releasing any Project water from Twin Lakes Reservoir, and does not plan on moving any additional Project water from the upper reservoirs to Pueblo. Movement of water will be adjusted according to the forecast and customer needs.

Mr. Vaughan showed pictures of the joint repairs at Pueblo Reservoir.

STATE LEGISLATION UPDATE

Lee Miller reported the first meeting of the Water Resources Review Committee (WRRC) will be on August 21, 2019, at the Colorado Water Congress summer meeting in Steamboat Springs. Topics for this meeting will be:

The WRRC meeting on September 11, 2019, will be on Colorado River Issues. On September 12, 2019, the WRRC will start the process for drafting potential legislation. The Board will be updated on more plans of the WRRC as they become known.

COLORADO RIVER ISSUES STATUS

Lee Miller reported both the State of Colorado and the Upper Colorado River Commission (UCRC) have begun steps necessary to implement the Demand Management Program (DMP).

The UCRC held a Demand Management Stakeholder Workshop in Salt Lake City on June 21, 2019. The Workshop included breakout sessions where participants discussed what was important to make a DMP work. The midyear UCRC workshop and regular meetings were held on Thursday, June 27 and Friday, June 28, 2019, respectively, at the Keystone Resort and Conference Center. Lee Miller was present at all of the meetings. Information on each of those meetings was attached to June 2019 report.

The Colorado Water Conservation Board (CWCB) hosted an Orientation Webinar Monday, July 15, 2019, for workgroup membership to provide an overview of the Drought Contingency Plan (DCP) process, and how demand management feasibility aligns with other efforts under the Upper Basin DCP. The Webinar also discussed the kickoff of the Workgroup process, and provided information to Workgroup membership about process and procedures. The Webinar was co-hosted in partnership with Colorado Water Congress, and was open to the public.

The first regional CWCB workshop has been scheduled for Thursday, August 22, 2019. This workshop will be held in conjunction with the summer conference of Colorado Water Congress, at the Steamboat Grand Hotel.

FRY-ARK IMPORTS UPDATE

Mr. Woodka reported Reclamation's May 1, 2019, projection for Project water was 84,000 acre-feet, and the latest estimate is 90,000-92,000 acre-feet. There is adequate storage in Turquoise Lake for the remaining imports and Reclamation does not plan on moving any additional Project water to Pueblo Reservoir.

As of July 16, 2019, about 76,000 acre-feet of Project water had been imported, and the Boustead Tunnel was still running above 700 cfs. Given those numbers, the target of 84,000 acre-feet should be reached before July 26, 2019 (the end of next week).

This means the District will release all Project water allocated this year. All entities requesting Project water have paid. As of July 16, only 1,227.30 acre-feet of Project water had been requested and released.

Water above the 84,000 acre-feet for allocations will be stored for allocation in 2020, unless conditions in the Arkansas River basin drastically change during the next few months.

It was suggested that the entities be notified that they will receive their full requests.
