## **ACTION ITEMS:**

AUTHORIZATION OF STIPULATION IN THE APPLICATION OF CPW AND PARKS AND WILDLIFE COMMISSION, CASE NO. 23CW3048

Mr. Peter Levish presented to the Board an action item recommending that the Board of Directors authorize Special Water Counsel to execute a stipulation with the Colorado Division of Parks and Wildlife and the Parks and Wildlife Commission (collectively, "CPW") in Case No. 23CW3048, Water Division 2, consenting to entry of a decree that is no less restrictive on CPW and no less protective of the District's water rights and interests than the proposed decree dated January 17, 2025.

A copy of the Proposed Decree was provided to the Board.

Mr. Clayton moved, seconded by Mr. Colosimo, to authorize Special Water Counsel to enter a stipulation with CPW consenting to the entry of a decree in Case No. 23CW3048 that is no less restrictive on CPW and no less protective of the District's water rights than the proposed decree dated January 17, 2025. Motion unanimously carried.

STATEMENT OF OPPOSITION IN THE APPLICATION OF UAWCD, CASE NO. 24CW3055 Mr. Peter Levish presented an action item recommending that the District Board authorize Special Water Counsel to file a Statement of Opposition to the Application of the Upper Arkansas Water Conservancy District in Case No. 24CW3055 (Water Division 2).

Mr. Karney moved, seconded by Mr. Clayton, that the District Board authorize Special Water Counsel to file a Statement of Opposition to the Application of the Upper Arkansas Water Conservancy District in Case No. 24CW3055. Mr. Greg Felt and Mr. Tom Goodwin recused themselves from the vote. Motion unanimously carried.

## STATE LEGISLATION UPDATE

Mr. Peter Levish gave an update to the Board. The first regular session of the 75th General Assembly convened on January 8, 2025. A copy of the deadline schedule for the 2025 session and the Colorado Water Congress Bill Status Sheet were provided to the Board.

## **COLORADO RIVER ISSUES**

Mr. Lee Miller gave an update to the Board:

On January 17, 2025, the Bureau of Reclamation (Reclamation) published the Alternatives Report to document the alternatives that were officially released on November 20, 2024, and are anticipated to be carried forward in the draft EIS for the ongoing Post-2026 Colorado River Operations NEPA process. Information submitted following the November 20, 2024, publication of the alternatives, such as the Upper Division States refinements reported on last month, has not been considered in this report. Reclamation will continue its efforts working with Colorado River Basin partners and stakeholders and will analyze information submitted after November 20, 2024. Additionally, Reclamation will also prepare the environmental impact analysis for the draft EIS.

The five anticipated alternatives are:

- No Action Alternative
- Federal Authorities Alternative
- Federal Authorities Hybrid Alternative
- Cooperative Conservation Alternative
- Basin Hybrid Alternative

The Upper Colorado River Commission is scheduled to meet on February 18, 2025, via webinar. Topics for the meeting will include the Drought Response Operations Agreement, the current Basin States Discussions and Post-2026 Process Updates and the future of the System Conservation Pilot Program. The meeting will be held without a Federal Commissioner, as Anne Castle, appointed by President Biden, has submitted her resignation

at the request of the Trump Administration and the resignation was accepted a week after President Trump's inauguration. No replacement has yet been nominated.
