Mr. Edelmann moved, seconded by Mr. Clayton the motion unanimously carried.

Public Hearing for 2022 Proposed Budget

Mrs. Noga explained the Board of Directors conducts a Public Hearing each year prior to adopting the annual budget to be in compliance with Colorado State Law C.R.S 29-1-108(1).

Chairwoman Nichols asked for a motion for the Finance Committee to recommend to the Board of Directors to set November 18, 2021, at 9:45 a.m. for the District and Enterprise Public Hearing of the 2022 Proposed Budget. Mr. Edelmann moved, seconded by Mr. Clayton the motion unanimously carried.
